VCS Serial Numbers of Carbon Dioxide Removals VCUs from the 1st Monitoring Report (2016-2021)

The following document specifies the VCS-certified serial numbers of VCS 2609 VCUs designated as Carbon Dioxide Removals (“removals”). This document and the project website were designed to make it quick and transparent to publicly trace back a retirement on the Verra Registry to an audited assurance and guarantee from the project proponent and independent auditor that these are the only removals VCUs generated and sold from the project over the monitoring period. The audited assurance guarantee is available on the project website and confirms the total number of removals issued.
